8. <u>New Business</u>

A. Pioneer Park Presentation by Hitchcock Design

The park district has engaged Hitchcock Design to put together the application package for an OSLAD grant for Pioneer Park. A representative from Hitchcock Design was present to show

the board the potential enhancements they would present to the State for the grant. Some of the proposed updates were improved pedestrian access to the park, improving the trails, improvements to the mini golf course, and replacement of the play equipment. They also plan to address the drainage in the fields and ageing infrastructure.

B. <u>Discussion/Approval of the use of LoVerde parking lot for Woodley Park</u> <u>Condominiums</u>

The Woodley Park Condominiums across the street from the LoVerde Center are having their parking lots repaved and are asking to use the LoVerde parking lot for their residents over a two-day period. The board asked if the park district should be given a certificate of insurance by the condominium association or be named as an additional insurer.

C. Discussion of Summer operations and programs

Considering the Covid 19 pandemic, staff asked for the board's input on what programs to try to run this summer. The board discussed the possibility of each department opening. The board decided not to open the pool. Regarding the summer concert series, the board discussed the possibility of having an end of summer concert, if State guidelines allow. The board also suggested pushing a couple of the concerts back into August in the even that larger groups are allowed to gather by that time. The same thing will be done for movies in the park as well. The board discussed many potential options for summer camps from smaller groups, bringing events/entertainment in instead of taking field trips, breaking up the kids into small groups, and staggering drop off times, in addition to adhering to social distancing and hand washing.

The IAPD guidelines have not come out yet but can be looked at when available. The park district has begun implementing some virtual programs such as dance, piano, and virtual preschool graduation. One on one golf lessons with social distancing was suggested as well as a virtual weight loss contest, and yoga classes outside with social distancing. The board was asked of the park district has the go ahead to open the outdoor tennis courts, to which they agreed. Also, the State will let us know when the batting cages can open.
